# The Island's Future Leaders Recognised by IoD Jersey

The IoD (Institute of Directors) Jersey 2025 Future Leaders scheme, sponsored by KPMG in the Crown Dependencies, culminated in a celebratory awards ceremony at the Royal Yacht Hotel. The event saw Deputy Inna Gardiner, former Minister for Children and Education and Chair of the IoD Alex Ruddy, presenting students with their certificates and awards, alongside representatives from KPMG in the Crown Dependencies and Andium Homes. Open to all Year 12 students, the scheme offers a unique opportunity to spend a week shadowing a Director or Senior Manager, providing invaluable career insight.

Over forty students were celebrated at the event, receiving certificates of participation, and a further six students were awarded Commended certificates. The ceremony also recognised two Year 6 student winners from the 2025 Jersey Oracy Network initiative *Speak Up Speak Out* – Jayden Rachuonyo and Amelia Reczynska – who each delivered inspiring presentations on "What equality means to me".
