



Shell Energy Promotion Terms and Conditions

May 2022

1. The Promotion

- **1.1.** The promoter of the promotion (the "**Discount**") is Shell EV Charging Solutions UK Ltd. (the "**Promoter**").
- **1.2.** The Promotion is available from 00.00 GMT on the 1 January 2021 until 23:59 GMT on the 31st of December 2022 (the "**Promotion Period**").

2. The Discount

- 2.1. The Discount of 30 GBP including VAT only applies to the purchase of a Home Charger in combination with an installation package as stated on the website https://shellrecharge.com/en-gb/ (the "Website").
- 2.2. Thee Discount only applies to purchases made online. The Discount does not apply when purchasing a Home Charger through other channels.
- 2.3. Only purchases that take place in the Promotion Period will be made to qualify for the Discount. The Discount is not applied (retrospectively) to purchases made outside of the Promotion Period (or have already taken place).
- 2.4. Only active Shell Energy Retail Limited (Shell Energy) Customers are eligible for the Discount. Customers can prove eligibility by submitting their Shell Energy account email addresses. The sole purpose of the email address submission is to validate a Participant's active account status with Shell Energy and the email address will not be recorded or stored by the Promoter. Shell Recharge Solutions' Privacy Policy applies to the processing of this data.
- **2.5.** The Discount is applied to a maximum number of two Home Chargers per customer.
- 2.6. The Discount will be included in the final offer drawn up in response to the request via the Website.

3. Additional Terms

- **3.1.** If for any reason any aspect of this Promotion is not capable of running as planned the Promoter may in its sole discretion cancel, terminate, modify or suspend the Promotion.
- 3.2. The Promoter and its associated agencies and companies will not be liable for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense or damage which is suffered or sustained (whether or not arising from any person's negligence) in connection with this Promotion, except for any liability which cannot be excluded by law
