



UK Holiday Prize Draw Terms and Conditions

June 2022

1. General

- **1.1.** These terms and conditions (hereinafter referred to as: the "**Terms and Conditions**") apply to the "EV holiday Prize Draw" (hereinafter referred to as: the "**Prize Draw**").
- 1.2. The Prize Draw is organised by Shell EV Charging Solutions UK Ltd., with its place of business located at Waterhouse Square, 138 142 Holborn, London, EC1N 2SW, The United Kingdom ("Shell Recharge Solutions").
- **1.3.** The Prize Draw is organised to promote the use of the Shell Recharge app and charge card.
- 1.4. The Prize Draw starts at 12:00 am on 8 June 2022 and ends on 23:59 10 July 2022 (the "Prize Draw Period"). All entries must be received during the Prize Draw Period. Any entries that are received after the end of the Prize Draw Period are automatically disqualified.

2. Description of the Prize Draw

2.1. The Prize Draw encourages participants to download the Shell Recharge app to find the answer to a question related to going on holiday with an electric vehicle. Participants should submit the answer including their personal details to the campaign landing page to have the opportunity to win 2 weeks of free charging. The winner can select the 2 weeks of free charging themselves, but the 2 weeks must be subsequent and take place between 15 July 2022 and 30 August 2022. The Prize Draw will be organised simultaneously in the Netherlands, Germany and France.

3. Participation

- 3.1. Participants can enter the Prize Draw by submitting the answer to the Prize Draw question and their personal details to a form on the campaign landing page that can be found on the Shell Recharge website (https://shellrecharge.com/en-gb/) in the public charging section.
- **3.2.** Each participant can only take part in the Prize Draw once, regardless of how many entries one submits. Duplicate entries will be removed.

- 3.3. By participating in the Prize Draw, you agree to be bound by these Terms and Conditions. Shell Recharge Solutions reserves the right to refuse entry, or refuse to award the Prize to anyone who does not comply with these Terms and Conditions.
- **3.4.** Participation in the Prize Draw is only open to residents of the United Kingdom aged 16 or older. Children under the age of 16 may only take part with the consent of a parent or guardian.
- **3.5.** Employees, including family members residing with such employees, of Shell Recharge Solutions, its subsidiaries, and anyone else involved in the organisation of the Prize Draw are excluded from participating in the Prize Draw.
- **3.6.** Participation in the Prize Draw is free of charge.

4. Designation of the winner

- **4.1.** Shell Recharge Solutions will select one (1) winner of the Prize described in Article 5 at random from all participants in the Prize Draw.
- **4.2.** These winners will be drawn after the end of the Prize Draw Period on 11 July 2022 by using a random winner selection tool.
- 4.3. After the draw, the Prize winners will be informed of their Prize on 11 July 2022 by email. Following this notification, the Prize will be sent to the winner within five (5) days. If a Prize winner cannot be contacted, is ineligible or fails to claim the Prize within fourteen (14) days from the time award notification was sent, the Prize may be forfeited and an alternative winner will be selected.

5. Prizes

- **5.1.** Each participant has the chance to win one of the following prizes (hereinafter referred to as "**Prize**" or "**Prizes**"):
 - (i) The prize is two (2) weeks of charging across the entire Shell Recharge roaming network, with a maximum of 1000kWh in total worth a maximum of £1,518. The prize will be presented in the form of a charge card, which may be used exclusively by the winner to charge one (1) vehicle.
- **5.2.** The total value of the array of Prizes is £1,518.
- **5.3.** A winner's right to receive a Prize is not transferable. It is not possible to redeem or exchange a Prize for substitute prizes or money.
