General information

Who may apply? EF University Preparation Abroad programs are open to students age 16 and over at course start date.

Students send in their enrollment details to Students send in their enrollment details to EF by phone, online on ef.com, by mail, at an EF office or in the EF planner, which can be accessed from price quotes sent by EF. The Organizer accepts theenrolment by sending the student a confirmation and initial invoice. A non-refundable Enrollment Fee of 395 € and cancellation Protection Fee of 195 € is due upon enrollment. The booking is final when EF has received the Enrolment Fee and the Program desorit. the Program deposit.

Students enrolling at a school in Australia are required by the Australian government to obtain medical insurance with an Australian company. Er Can offer students Allianz Private Insurance for purchase.

Health formalities Legal guardians of students under the age of 18 (19 in Canada) will be required to sign a medical liability waiver.

The student may be under obligation to provide proof of vaccination. EF reserves the right to repatriate the student at its own expense if necessary for health reasons. The courses are suitable for students with reduced mobility as long as the students are autonomous.

Changes of the program 60 days or more before departure will result in a rebooking fee of 100 & and 250 & if less than 60 days before departure. In the event of a change of course start date, the cancellation conditions will be applied to the original course start

Students making changes to their course after the start date will be charged a change fee of 200 €. There is no refund for downgrades (e.g. change from Intensive course to General course or change to a less expensive destination).

Withdrawals after program start To withdraw from the EF program, students must inform the EF School Director and sign the course change notification form. The date of withdrawal is defined as the Saturday of the week of the last day of class attendance.

Charges other than Course Fee and accommodation supplement are non-refundable.

For all destinations except in the USA A withdrawal is effective upon an 8-weeks' notice period. For the period afterwards, the Tuition Fee and 50% of the Student Services Fee will be refunded if the program is terminated before the Withdrawal Deadline. For later withdrawals no fees will be refunded.

For students who withdraw after the first four weeks but before or at the mid-point of the program (50% of the total booked program duration, or after 60% of total duration for programs in San Francisco) EF will retain a prorated amount of the Course Fee.

For students who withdraw after the mid-point of the program (50% of the total booked program duration, or after 60% of total duration for programs in San Francisco) EF will retain all charges.
