Investment policy

The Fund pursues a dedicated deep value approach. It invests in Japanese companies that, according to the fund manager's analysis, trade at a significant discount to their calculated intrinsic value. Shares are selected according to a rational economic assessment of each company's business fundamentals. Short-term stock price fluctuations do not play a role in the decision-making process. The portfolio has virtually no overlap with widely used Japanese equity indices.

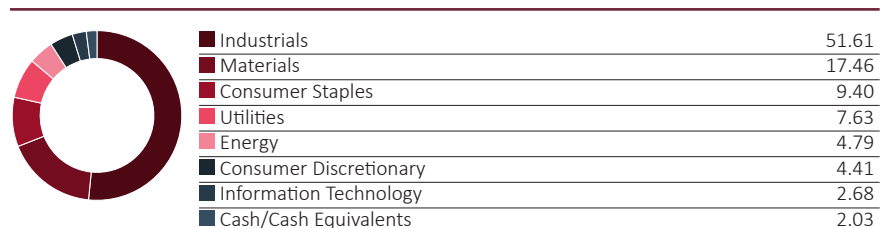


Net performance in JPY ²⁾

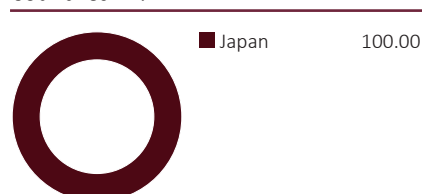

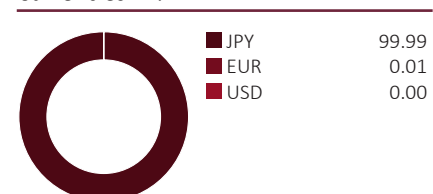
