

PRO14 is the organization responsible for running the Guinness PRO14 Rugby Championship. It is an annual rugby union competition involving teams from Ireland, Italy, Scotland, South Africa, and Wales. The league is one of the three major professional rugby leagues in Europe.

In 2020, CVC, a world leader in private equity (with over \$100B assets under management), acquired a 28% stake in PRO14. The strategic investment allows both PRO14 Rugby and the rugby unions to continue to invest in the sport, to achieve its potential over the long term.

The Challenge

PRO14 is a growing business and with the additional CVC investment, the finance team needed a platform to consolidate their data, provide the advanced analytics to support their growth, and deliver efficiency by streamlining the reporting procedures.

The limited reporting capability in the existing ERP was prohibiting them from analyzing performance in the way they needed, with no advanced way of visualizing that data. The process of gathering information was laborintensive and the business wanted to free up time to analyze data and allow them to make more informed decisions.

With the CVC investment, the demands on their finance team increased and PRO14 required a more streamlined way of accessing real-time data. Also, with the growth plans, they needed a solution to match that ambition.
